Here is a round up of the week with vital company information.

On March 30, 2020, the Chamber of Deputies unanimously adopted <a href="Bill">Bill</a>
<a href="Piston">7532</a> introducing an aid scheme for companies experiencing temporary financial difficulties linked to the COVID-19 crisis. Aid to SMEs is also provided for in the bill, which aims to quickly and without bureaucratic burden support businesses affected by the current health crisis. The budgetary envelope mobilized by the State to come to the rescue of SMEs amounts to 300 million euros (among the 8.8 billion announced for the <a href="Stabilization Plan">Stabilization Plan</a>).

Aid of up to 500,000 euros per company is planned to deal with the situation. The allocation of the planned aid is nevertheless subject to a series of conditions. These are explained in a video made available in 5 linguistic versions by the House of Entrepreneurship of the Chamber of Commerce in collaboration with the Ministry of the Economy, Directorate General of the Middle Classes:

A very interesting article in *Paperjam* on 1st April, 2020 by Thierry Labro said the following:

The Minister of the Economy, Franz Fayot, made a gesture for young innovative companies, Tuesday in the Chamber of Deputies. But what reality will it take? The question remains.

With the still slightly wavering voice of those who are not yet familiar with opposition critics or fellow citizens, the new Minister of the Economy, <a href="Franz">Franz</a>
<a href="Fayot">Fayot</a> (LSAP), <a href="stopped for a moment on start-ups">stapped for a moment on start-ups</a>, <a href="Tuesday afternoon">Tuesday afternoon</a>, <a href="when when the stabilization pact bill is voted on">when the stabilization pact bill is voted on</a>. He had just promised faster, wider and less bureaucratic aid. For start-ups, the minister decided to increase the State's

commitment from 50% of a total capped at 800,000 euros to 70%. In a tweet dated 31st March, 2020 he tweeted

"I decided to adjust the financial aid for young innovative companies by providing up to € 800,000 to co-finance at least 70% (before the crisis it were up to 50%) of all costs borne by a start-up for the duration of its project @ccluxembourg @StartupLu @uel\_lu"

But it is not that simple. Because the law on research and innovation is open to innovative companies less than five years old, which are generally called start-ups, but not under any conditions.

So far, to claim to cover 50% of its costs, the start-up had to either demonstrate, by an outside expert, that it was bringing a breakthrough technology, or that its research and development costs represented minus 10% of its costs over three years, or over a year provided that its accounts are certified by an external auditor.

This is probably what explains why the device is not widely used by start-ups, according to the latest annual report from the Ministry of the Economy available. In that of 2018, at a time when it was not yet widely known, only 5% of the 86 projects (involving 100 million euros in costs) came from innovative companies. That year, the device cost the state 34 million euros.

Start-ups, like other companies, can claim leave for family reasons or partial unemployment, erected by the Minister as a pillar of these temporary aid.and therefore this reimbursement of 70% of the costs.

Another olive branch was given out today 2nd April, 2020

A fantastic initiative by an Independent person **Mr Giovanni Petri** was to start a Facebook page dedicated to SME/Self employed persons, "**Rescue Independants and Start-Ups**" which has gathered over 6000 members in less than a week. This in turn has now proved so popular that an ASBL has formed which everyone can join free of charge here: http://alliancup.org
